Position One: Immigrant Rights Campaign Youth Organizer

The Immigrant Rights Campaign is a youth led organizing project that works with immigrant low-income communities of color. Youth Leaders will conduct research by collecting community opinions, identifying issues and solutions, and work towards immigrant rights policy. Youth leaders will design projects for the community and will be supported throughout the process, so no experience necessary!

Applicants must be:

- Must be between the ages of 16-24
- San Francisco resident
- Must have an interest in immigrant rights
- Passionate about being a LEADER and committed to bringing solutions to your community!
- Interested in learning media skills
- Can be actively on probation in SF County (not a requirement, does not include court probation)
- Can be undocumented

Position Two: Health Rights Campaign Youth Organizer

The Health Rights Campaign conducts community-based research, policy, and organizing. The Health Rights Campaign focuses on tobacco education, specifically how low-income communities of color are targeted by tobacco companies. Youth organizers conduct research by collecting community opinions, identifying health effects, and creating policies on how to stop the tobacco industry from targeting low-income communities of color. Youth organizers will survey their communities, complete a photo project, and conduct interviews. They will use the data they have collected to create a policy that they feel best protects the health of their community.

Applicants must be:

- Must be between the ages of 16-24 years old
- Must be a San Francisco Resident
- Passionate about being a LEADER and committed to improving the health of the community!
- Can be actively on probation in SF County (not a requirement, does not include court probation)
- Can be undocumented

Position Three: Community Outreach Worker

Position Description: Community Outreach Workers are a group of young leaders who work directly in the community. As front-line staff, Outreach Workers provide youth and their allies with resources and information and employment opportunities. Outreach Workers inform the community about CHALK programs and build connections throughout San Francisco. Also, they will be responsible for facilitating a youth-led employment dropin program that helps 16-24 years olds find a job.

GENERAL RESPONSIBILITIES:

- Public Speaking: Conduct presentations about CHALK programs and services
- Assess community needs and identify available resources
- Connect community members with resources and information
- Build relationships with youth and adults in the community
- Develop outreach plans and strategies
- Participate in various community meetings and public events
